1. Title: **NGOs in Theory and Practice**

2. Content and Arrangements: This course will be taught in English. It is an elective course open to Bachelor and Master students of social work, public administration, sociology and political sciences. The preferred number of students is 30.

Students will learn about the role of Non-Governmental Organisations in different sectors, in particular social and environmental work. They will learn about Chinese and international NGOs and their cooperation with Government and the private sector.

First session: Introduction and NGOs in the context of social work and social science theories (KUHN, Berthold; Zhang Yangyong)

Second session: NGOs in the context of social and political science theories (KUHN, Berthold)

Third session: Areas of NGO expertise and work, examples from Europe and China (KUHN, Berthold)

Fourth session: International NGOs at transnational level/ int. NGOs in China (KUHN, Berthold)

Fifth session onwards: students' group presentations under guidance of KUHN, Berthold and ZHANG Yangyong).

regular attendance, group presentation (30 min, 10 min. per student)

summary paper 2500 English words per student plus abstract in Chinese and English
